



## **BIG LEAGUE DREAMS GILBERT**

### **PLAYER/TEAM REFUND POLICY**

Without giving us prior notice, The Town of Gilbert closed down Big League Dreams on Friday July 7, 2017 due to alleged safety issues with the exterior walls on each field. BLD has made every attempt to remain open for our players, and we expected to prevail with every attempt. The most recent attempt was the hiring of an independent structural engineering company to conduct load testing on the walls. Contrary to prior reports, the testing (see picture below) has established that the exterior walls are not only safe but exceed any and all code and local standards. (In most instances the safety factor was exceeded by 2 to 4 times what is required by code.)

Although we have proven that the exterior walls are safe to reopen the park, due to the remaining uncertainty of opening soon and the lapse of time that has transpired, we feel that it is prudent and fair for BLD to now offer refunds to all customers for leagues that have not been able to be completed.

Below is the refund policy and procedure that you can follow:

1. Fill out the Refund Request Form completely with all information requested.
2. BLD will review the refund request and confirm the amount of refund due based on the information outlined below and mail a refund check directly to you. (Please allow up to two weeks to receive the refund.)

Our normal refund policy is based on the amount of games actually played against the total number of regular season games (9). Due to this unforeseen issue, BLD Gilbert has come up with what we feel is a fair refund policy. These refunds will be based on actual money paid.

- **If your team has played 4 weeks or less, a full refund will be given.**
- **If your team has played 5 weeks or more, a 50% refund will be given.**
- **No refund will be issued if you have played 9 regular season games. (Teams that made the playoffs will receive a free team fee for a league upon reopening.)**
